Offer of Acharya Commodity for Swapping of local Bullion Delivery

Acharya Commodity, has agreed to provide the service of “Swapping of local Bullion delivery to Exchange approved MCX Delivery within Exchange vaults”. Acharya Commodity has offered to take bullion delivery which is of local refinery and not a good delivery as per MCX norm on the exchange and instead in return would provide the delivery which is a good delivery on the exchange designated vault i.e. G4S, subject to following:

1. Request letter and undertaking to be provided on the client's and member's letter head for the purity of the Bullion to Acharya Commodity.
2. The Bullion will be checked by assaying centre at Acharya Commodity @ Rs 100/- per 1 kg Gold Bar or any other authorised assaying centres accepted by Acharya Commodity, a list of such centres, subject to change at the discretion of Acharya Commodity is given below.
3. Acharya Commodity will charge for swap of non-approved gold bars delivery from open market to vaulted Exchange approved delivery at rate varying between min of Rs. 1000/- to Rs. 3000/- max per 1 kg depending on the purity of the bullion (Minimum purity should be 995).
4. The delivery required to be swapped has to be in bar form only and it will be **the sole discretion of Acharya Commodity as to whether accept or reject the aforesaid facility** provided by them.
